Loon Dataset License Agreement for Non-Commercial Use (April 2020)

TERMS AND CONDITIONS FOR USE, REPRODUCTION, AND DISTRIBUTION

By exercising the Licensed Rights (defined below), You accept and agree to be bound by the terms and conditions of this Loon Dataset License Agreement for Non-Commercial Use ("Loon Dataset License"). To the extent this Loon Dataset License may be interpreted as a contract, You are granted the Licensed Rights in consideration of Your acceptance of these terms and conditions, and Loon grants You such rights in consideration of benefits Loon receives from making the Licensed Material available under these terms and conditions.

Section 1 – Definitions.

- a. **Adapted Material** means material subject to Copyright and Similar Rights that is derived from or based upon the Licensed Material and in which the Licensed Material is translated, altered, arranged, transformed, or otherwise modified in a manner requiring permission under the Copyright and Similar Rights held by Loon. For purposes of this Loon Dataset License, where the Licensed Material is a musical work, performance, or sound recording, Adapted Material is always produced where the Licensed Material is synched in timed relation with a moving image.
- b. **Adapter's License** means the license You apply to Your Copyright and Similar Rights in Your contributions to Adapted Material in accordance with the terms and conditions of this Loon Dataset License.
- c. **Copyright and Similar Rights** means copyright and/or similar rights closely related to copyright including, without limitation, performance, broadcast, sound recording, and Sui Generis Database Rights, without regard to how the rights are labeled or categorized. For purposes of this Loon Dataset License, the rights specified in Section 2(b)(1)-(2) are not Copyright and Similar Rights.
- d. **Effective Technological Measures** means those measures that, in the absence of proper authority, may not be circumvented under laws fulfilling obligations under Article 11 of the WIPO Copyright Treaty adopted on December 20, 1996, and/or similar international agreements.
- e. **Exceptions and Limitations** means fair use, fair dealing, and/or any other exception or limitation to Copyright and Similar Rights that applies to Your use of the Licensed Material.
- f. **Licensed Material** means the artistic or literary work, database, or other material to which this Loon Dataset License is being applied.
- g. **Licensed Rights** means the rights granted to You subject to the terms and conditions of this Loon Dataset License, which are limited to all Copyright and Similar Rights that apply to Your use of the Licensed Material and that Loon has authority to license.
- h. **Loon** means Loon LLC.
- i. **Non-Commercial** means not primarily intended for or directed towards commercial advantage or monetary compensation. For purposes of this Loon Dataset License, the exchange of the Licensed Material for other material subject to Copyright and Similar

Rights by digital file-sharing or similar means is Non-Commercial provided there is no payment of monetary compensation in connection with the exchange.

- j. **Production Systems** means computer, network, and datacenter infrastructure, and other systems primarily intended to provide a product or service to customers or other third parties, even if no monetary compensation is received for such a service.
- k. **Share** means to provide material to the public by any means or process that requires permission under the Licensed Rights, such as reproduction, public display, public performance, distribution, dissemination, communication, or importation, and to make material available to the public including in ways that members of the public may access the material from a place and at a time individually chosen by them.
- l. **Sui Generis Database Rights** means rights other than copyright resulting from Directive 96/9/EC of the European Parliament and of the Council of 11 March 1996 on the legal protection of databases, as amended and/or succeeded, as well as other essentially equivalent rights anywhere in the world.
- m. **You** means the individual or entity exercising the Licensed Rights under this Loon Dataset License. **Your** has a corresponding meaning.

Section 2 – Scope.

a. License grant.

1. Subject to the terms and conditions of this Loon Dataset License, Loon hereby grants You a worldwide, royalty-free, non-sublicensable, non-exclusive, irrevocable license to exercise the Licensed Rights in the Licensed Material to:
 - A. use, reproduce and Share the Licensed Material, in whole or in part, for Non-Commercial purposes only; and
 - B. produce, reproduce, and Share Adapted Material for Non-Commercial purposes only.
2. Exceptions and Limitations. For the avoidance of doubt, where Exceptions and Limitations apply to Your use, this Loon Dataset License does not apply, and You do not need to comply with its terms and conditions.
3. Term. The term of this Loon Dataset License is specified in Section 6(a).
4. Media and formats; technical modifications allowed. Loon authorizes You to exercise the Licensed Rights in all media and formats whether now known or hereafter created, and to make technical modifications necessary to do so. Loon waives and/or agrees not to assert any right or authority to forbid You from making technical modifications necessary to exercise the Licensed Rights, including technical modifications necessary to circumvent Effective Technological Measures. For purposes of this Loon Dataset License, simply making modifications authorized by this Section 2(a)(4) never produces Adapted Material.
5. Downstream recipients.
 - A. Offer from Loon – Licensed Material. Every recipient of the Licensed Material automatically receives an offer from Loon to exercise the Licensed Rights under the terms and conditions of this Loon Dataset License.

- B. No downstream restrictions. You may not offer or impose any additional or different terms or conditions on, or apply any Effective Technological Measures to, the Licensed Material if doing so restricts exercise of the Licensed Rights by any recipient of the Licensed Material.
 - 6. No endorsement. Nothing in this Loon Dataset License constitutes or may be construed as permission to assert or imply that You are, or that Your use of the Licensed Material is, connected with, or sponsored, endorsed, or granted official status by, Loon or others designated to receive attribution as provided in Section 3(a)(1)(A)(i).
- b. **Other rights.**
- 1. Moral rights, such as the right of integrity, are not licensed under this Loon Dataset License, nor are publicity, privacy, and/or other similar personality rights; however, to the extent possible, Loon waives and/or agrees not to assert any such rights held by Loon to the limited extent necessary to allow You to exercise the Licensed Rights, but not otherwise.
 - 2. Patent and trademark rights are not licensed under this Loon Dataset License.
 - 3. To the extent possible, Loon waives any right to collect royalties from You for the exercise of the Licensed Rights, whether directly or through a collecting society under any voluntary or waivable statutory or compulsory licensing scheme. In all other cases Loon expressly reserves any right to collect such royalties, including when the Licensed Material is used other than for Non-Commercial purposes.

Section 3 – License Conditions.

Your exercise of the Licensed Rights is expressly made subject to the following conditions.

a. **Attribution.**

- 1. If You Share the Licensed Material (including in modified form), You must:
 - A. retain the following if it is supplied by Loon with the Licensed Material:
 - i. identification of the creator(s) of the Licensed Material and any others designated to receive attribution, in any reasonable manner requested by Loon (including by pseudonym if designated);
 - ii. a copyright notice;
 - iii. a notice that refers to this Loon Dataset License;
 - iv. a notice that refers to the disclaimer of warranties;
 - v. a URI or hyperlink to the Licensed Material to the extent reasonably practicable;
 - B. indicate if You modified the Licensed Material and retain an indication of any previous modifications; and
 - C. indicate the Licensed Material is licensed under this Loon Dataset License, and include the text of, or the URI or hyperlink to, this Loon Dataset License.
- 2. You may satisfy the conditions in Section 3(a)(1) in any reasonable manner based on the medium, means, and context in which You Share the Licensed Material. For example, it may be reasonable to satisfy the conditions by providing a URI or hyperlink to a resource that includes the required information.

3. If requested by Loon, You must remove any of the information required by Section 3(a)(1)(A) to the extent reasonably practicable.
 4. If You Share Adapted Material You produce, the Adapter's License You apply must not prevent recipients of the Adapted Material from complying with this Loon Dataset License.
- b. **Limited Non-Assert:** In consideration for access to this Licensed Material and/or this royalty-free license from Loon, You (also on behalf of Your successors and assignees of any rights protecting Your Adapted Material) (i) agree not to prepare, initiate, assert, or otherwise support any claim against Loon or any of its affiliates, successors, or assignees, for infringement, misappropriation or other violation of any rights protecting Your Adapted Material, and (ii) grant Loon and the other parties in section 3.b(i) a worldwide, royalty-free, non-exclusive, irrevocable license to such rights, with such license becoming effective only if You breach the obligations of 3.b(i).

Section 4 – Sui Generis Database Rights.

Where the Licensed Rights include Sui Generis Database Rights that apply to Your use of the Licensed Material:

- a. for the avoidance of doubt, Section 2(a)(1) grants You the right to extract, reuse, reproduce, and Share all or a substantial portion of the contents of the database for Non-Commercial purposes only;
- b. if You include all or a substantial portion of the database contents in a database in which You have Sui Generis Database Rights, then the database in which You have Sui Generis Database Rights (but not its individual contents) is Adapted Material; and
- c. You must comply with the conditions in Section 3(a) if You Share all or a substantial portion of the contents of the database.

For the avoidance of doubt, this Section 4 supplements and does not replace Your obligations under this Loon Dataset License where the Licensed Rights include other Copyright and Similar Rights.

Section 5 – Disclaimer of Warranties and Limitation of Liability.

- a. **Unless otherwise separately undertaken by Loon, to the extent possible, Loon offers the Licensed Material as-is and as-available, and makes no representations or warranties of any kind concerning the Licensed Material, whether express, implied, statutory, or other. This includes, without limitation, warranties of title, merchantability, fitness for a particular purpose, non-infringement, absence of latent or other defects, accuracy, or the presence or absence of errors, whether or not known or discoverable. Where disclaimers of warranties are not allowed in full or in part, this disclaimer may not apply to You.**
- b. **To the extent possible, in no event will Loon be liable to You on any legal theory (including, without limitation, negligence) or otherwise for any direct, special, indirect, incidental, consequential, punitive, exemplary, or other losses, costs, expenses, or damages arising out of this Loon Dataset License or use of the Licensed Material, even if Loon has been advised of the possibility of such losses, costs, expenses, or damages. Where a limitation of liability is not allowed in full or in part, this limitation may not apply to You.**

- c. The disclaimer of warranties and limitation of liability provided above shall be interpreted in a manner that, to the extent possible, most closely approximates an absolute disclaimer and waiver of all liability.

Section 6 – Term and Termination.

- a. This Loon Dataset License applies for the term of the Copyright and Similar Rights licensed here. However, if You fail to comply with this Loon Dataset License, then Your rights under this Loon Dataset License terminate automatically.
- b. Where Your right to use the Licensed Material has terminated under Section 6(a), it reinstates:
 - 1. automatically as of the date the violation is cured, provided it is cured within 30 days of Your discovery of the violation; or
 - 2. upon express reinstatement by Loon.

For the avoidance of doubt, this Section 6(b) does not affect any right Loon may have to seek remedies for Your violations of this Loon Dataset License.

- c. For the avoidance of doubt, Loon may also offer the Licensed Material under separate terms or conditions or stop distributing the Licensed Material at any time; however, doing so will not terminate this Loon Dataset License.
- d. Sections 1, 5, 6, 7, and 8 survive termination of this Loon Dataset License.
